# Town of Covington Monthly Meeting of the Covington Town Board November 8, 2011

The monthly meeting of the Covington Town Board was held on Tuesday November 8, 2011 at the Covington Town Building. Present were Councilpersons Paul Tobias, Larry Warren, Sharon West and Brian Murphy. Also present was Supervisor Jerry Davis, Town Clerk Amy Wiedrich, Highway Superintendent Mike Bell and residents Karl Smith and Jim McIlroy.

The Pledge of allegiance opened the meeting at 7:30 p.m.

Supervisor Davis opened the public Hearing on overriding the tax cap.

Supervisor Davis then opened the public hearing on the Pavilion Fire Contract.

Supervisor Davis also opened the public hearing on the 2012 budget.

- \* Supervisor Davis mentioned that he and Mike have been discussing options for the issues on Wallace Road. Mike does have some more signs he can put up and he would like to put the posts back and remove the large rocks.
- \* Senator Gallivan will be meeting Synergy on Monday November 21, 2011
- \* Jerry mentioned that Debbie is home and recuperating from her surgery.
- \* Jerry talked to the sheriff about the robberies in our area.

- \* Mike advised that the laser equipment can be rented for \$75.00 a day or \$2100 to purchase, Board suggested to rent it for a couple days to make sure he likes it before purchasing it.

Hearing nothing, On a motion of Councilperson Tobias, seconded by Councilperson Warren the following resolution was
